NCCAT Executive Director Meets Jean Powell

NCCAT Executive Director Dr. M. Brock Womble met with Mrs. Jean Powell and her family members on September 28 in Wilmington, North Carolina. Dr. Womble spoke about the past, present, and future of NCCAT for North Carolina teachers.

In 1983, while serving as North Carolina Teacher of the Year, Mrs. Powell, of Clinton, was invited to address the Commission on Education and Economic Growth about physical improvements needed in schools. Mrs. Powell made a suggestion during

her speech about the idea for NCCAT, which was later established by the North Carolina legislature.

In his remarks Dr. Womble informed the audience of NCCAT's history, current status, and future as a recognized national leader in professional development. Educators across North Carolina often convey to him that they consider NCCAT to be the home for North Carolina teachers.

After meeting Mrs. Powell, Dr. Womble expressed the following, "It was an honor to meet Mrs. Powell. We deeply appreciate her strong enthusiasm for NCCAT which she has always displayed. We constantly seek to emulate that enthusiasm for teachers while providing high-quality professional development across North Carolina."



MESSAGE

Dear Friends of NCCAT,

It has been an exciting and notable year at The North Carolina Center for the Advancement of Teaching. We have celebrated thirty years of providing high-quality professional development for North Carolina teachers. NCCAT continues to focus on providing the development and support that are essential to retaining skilled teachers in the classroom. This year also marked the appointment of the seventh Executive Director of NCCAT, Dr. M. Brock Womble. Dr. Womble began his tenure in January 2016 after more than twenty years of experience in public education in North Carolina. Upon joining NCCAT, he immediately began seeking input from school districts regarding their most significant professional development needs for teachers.

NCCAT's professional development programs have become even more critical as teachers seek new and innovative ways to engage student learning in an increasingly digital age. NCCAT participant Sabrina Thomas of Green Valley Elementary School in the Watauga County Schools explained, "It doesn't matter whether it's your first year of teaching or your twenty-third year of teaching, you're going to walk away from here with new knowledge and new ideas to keep your teaching fresh and exciting." Thomas' comment is an example of the many positive thoughts teachers share about their professional development experiences at NCCAT.

During the 2015–2016 academic year, NCCAT served 117 school districts (including three federal districts) in all 100 counties with high-quality professional development primarily focused on early grades literacy and digital learning. Without any budget increase, NCCAT served far more teachers (34 percent increase) than in the previous year through our residential campuses, online, and school-based programming. When those numbers are disaggregated, 20 percent growth was seen in our core residential-based programming on both the Cullowhee and Ocracoke campuses. Additionally, NCCAT realized increases in digital learning (42 percent), early grades literacy (32 percent), and charter school (123 percent) participants. These increases were a direct result of our diligent outreach to schools and school districts.

NCCAT will continue to reach out to schools, school districts, and curriculum leaders to determine the professional development needs of North Carolina teachers. Our goal is to design programming based upon the direct feedback we receive from our participants and liaisons throughout North Carolina. We will continue to focus on bringing teachers together from across the state to enhance their skills to serve North Carolina students.

We want to thank the NCCAT Board of Trustees and Board of Directors of the Development Foundation of NCCAT for their support and commitment. We look forward to a bright future for NCCAT and North Carolina teachers.




