MESSAGE

NCCAT more than doubles number of teachers served from two years ago

The number of teachers served by the North Carolina Center for the Advancement of Teaching more than doubled from 1,720 in 2012–2013 to 3,556 in 2014–2015. NCCAT, which provides high-quality professional development that allows teachers to become active learners, also saw participation more than double in programs focused on key state initiatives: digital learning and early grades literacy.

We have implemented early grades literacy programs such as "Engaging Parents in Early Grades Literacy," "Reading, Writing, and Ready by Third Grade: Early Grades Literacy Instruction," along with the addition of a senior literacy specialist to the faculty. All programs are designed to support the North Carolina Read to Achieve Program goal of ensuring "That every student read at or above grade level and continue to progress in reading proficiency so that he or she can read, comprehend, integrate, and apply texts needed for secondary education and career success."

NCCAT advances classroom instruction by sharing the latest digital tools, skills, and knowledge. We continue to host programs such as "Google Tools in Schools" and "Catching Up With Your Students: Digital Learning" that provide educators across North Carolina the chance to collaborate and develop techniques to improve digital learning instruction.

NCCAT Online was introduced in 2014. As an extension of our face-to-face programming and our current focus on digital learning and early grades literacy, NCCAT has introduced a series of courses designed to be immediately helpful to teachers who are seeking new knowledge. These courses are hosted on the NCCAT Online Learning Portal and are open to any North Carolina public or charter school teacher at no cost to the teacher or the school.

In our nearly thirty-year history, NCCAT is best known for teachers who learn by doing and work collaboratively to discover education insights—through residential, online, and school-based experiences. This knowledge then spreads to classrooms across the state to help children achieve more. We work to help schools find solutions and improvements.

We will continue to focus on programs designed to enhance student achievement by treating teachers as professionals and by giving them the support they need to be effective in the classroom.





The boxes combined total 300 different activities. These Burke County teachers were able to have time while in Cullowhee to include four or five different written response activities for each reading level.
